#### **Item 4 – Rules of Entry**

##### **Who can enter?**

Entry is available to any entrant who completes rider registration in the 2018 Transmoto 8-Hour @ Bright, Vic, on Saturday April 28, 2018 or Sunday April 29, 2018, and who is a resident of Australia aged 18 years but excludes:

##### **How Can I enter?**

**When will the prize be drawn?**

The prize will be drawn on Sunday April 29, 2018, by 7.00pm AEST during presentation on ground at the 2018 Transmoto 8-Hour @ Bright event site . The first valid entry will receive a prize. The promoter's decision is final and no correspondence will be entered into.

**What happens if I no longer wish to take part in the competition?**

**How do I know if my entries have been accepted?**

**What happens once my entry is received?**
